Engaging with the community

In this issue of Mimitaro, we talked to Mr. Edward Iwaskow (resident of Otsu) who is a volunteer firefighter in Otsu.



I married my Japanese wife who studied abroad in Canada, came to Japan with an intension just to experience the country, but before I knew it, it has been 14 years. We run an English conversational school, do household

chores and raise kids together. There are slight cultural differences in daily life that cause confusion, but I have successfully overcome these situations by understanding the differences. Moreover, what adds colour to my daily life is the relationship I have with my neighbours.

My neighbours are all very friendly who have been living in the community and helping each other out for half a century. Our family is also a part of this community and we take part in activities carried out in our neighbourhood. Among them, my favourite is the local sports day event. There are not many young residents in our neighbourhood so we are valuable members to our local team and do our best with the support we receive. Also, during regional clean-up, as I am tall, my neighbours are happy to have me in charge of cleaning high shelves, windows and slopes. In the midst of these activities, a neighbour approached me and asked, "Ed, you are young, fast at running, and seem strong. Do you want to join the volunteer fire department?" I was a volunteer firefighter in Canada for 4 years since I was 18 years old so I was delighted to become a member and am now in my tenth year as a member of my regional volunteer fire department.

Volunteer firefighters have their separate jobs, however, during disasters such as fires, earthquakes, and typhoons, we assist residents with evacuation guidance and rescue. For this reason, we are called to prepare for emergencies when there is a fire or risk of a disaster. Other duties include regularly patrolling the neighbourhood in a fire engine, training for forest fires, and visiting households in the district to inform residents of disaster prevention. Therefore, I am familiar not only with evacuation shelters, but the local area and residents in my neighbourhood as well.

Duties of a volunteer firefighter are slightly different between Canada and Japan. My hometown is a rural island in Canada, taking approximately 30 minutes for a firefighter to arrive by boat or helicopter. Therefore, in the case of fires, accidents, blackouts and water disasters, a volunteer firefighter rushes to the scene and works on the front lines. In Japan, a qualified firefighter is mainly in charge, while a volunteer firefighter offers support. During a fire, a volunteer firefighter is responsible for water supply and traffic guidance to help put out the fire and does not go into the fire. In both countries, however, the appealing factor of a volunteer firefighter is the cooperative spirit amongst team members.

After a fire has settled, the duty of a volunteer firefighter is also to patrol on-site for 24 hours so it does not catch fire again. Team members patrol the site and spend time gathered in a circle together. During this time, residents in the neighbourhood kindly offer instant noodles and cookies for the service we provide. The moment of understanding amongst many people after a fire is safely put out is exceptional. We are amazed when we receive the paper in early dawn and see the article about the fire published in the morning paper.

Other than being a member of the volunteer fire department, I am also a member of the community association and PTA. Although voluntary, I feel the operation of these activities is difficult to manage as it is a heavy burden on members since we cannot easily refuse even if we are busy. It is also tough because all groups carry on the same events and activities despite the decrease in number of members compared to the This brings us to the problematic situation past. where "We all don't want to do it, but can't change it because it is how it has always been done." Japan has a culture to bear difficult or unpleasant situations, a culture to continue without making changes, with a good aspect of tradition being passed down through generations, but depending on the situation, it is also important to be flexible to change.

As a member of my community that I love, I would like to continue to support each other and live a happy life.

Make Use for Contact Notifications!

★ COVID-19 Contact Confirming App COCOA

When the app is installed into your smartphone, you will be able to receive notices if you had a possibility of coming in contact with someone who tested positive with COVID-19 while your privacy is considered. You will be able to receive prompt support from the public health office, such as undergoing testing.

★ Moshi-Sapo Shiga

When you scan the QR code displayed at facilities or event venues within Shiga prefecture, you will receive a warning message from the prefectural government if an infected person who used the same venue at the same time and day as you had was identified.

Shop wisely with My-no. Point Program!

If you obtain a My-number card and reserve apply for the My-number Point Program ("Myna-pointo"), you will receive a maximum of 5000 yen worth of points (25% grant rate) for purchases or charges made on your selected cashless service.

•You will be granted up to 1000 yen worth of additional points if you make purchases or charges within the prefecture.
